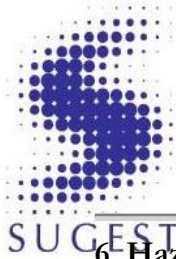

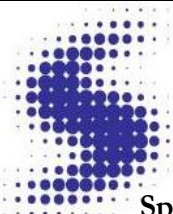

### 10. Handling and Storage

Keep in a tightly closed container. Protect from physical damage. Store in a cool, dry, ventilated area away from sources of heat, moisture and incompatibilities agents. Use only with appropriate protective equipment. Do not use in unventilated areas, walk in coolers or confined spaces. observe all warnings and precautions listed for the product.

Cocoamidopropyle betaine is stored only in vented containers and transferred only in a prescribed manner and never return unused coco amido propyl betaine to original container ,empty drums should be triple rinsed with water before discarding

Storage store drum in cool area out of direct sunlight and away from combustible ,for bulk storage refer to FMC technical bulletins .

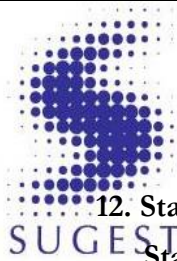
